## MEMBERSHIP OF THE TRUST

Please read the following explanatory notes:

1 The Trust is a Company limited by guarantee, and every member undertakes to contribute a sum, not exceeding £1, to the Company's assets if it should be wound up. This liability continues for a year after ceasing to be a member.

2 Admission to membership is at the discretion of the Council of Management.

3 There are **two ways** of becoming an Ordinary member:

(a) **You may apply for membership by paying a minimum subscription of £10. The membership subscription will be payable annually on 1st November each year, but a person who has been in membership for less than 6 months will not be required to pay again in the year of admission.**

**Please note** that a person paying more than the required minimum cannot use this payment as an advance against future years' subscriptions. All payments are regarded as donations to the Trust in the year in which they are received.

(b) **You may make a payment by standing order amounting to at least £10 per annum.** If you are **already** contributing to the Trust in this way you may apply for membership without any additional payment (but please indicate this on the form overleaf). If you decide to pay by S.O. please submit the completed form with your application, so that it can be recorded before being forwarded to your bank. Membership will come into operation on the date of the first payment. Membership will cease when a member cancels his or her regular payment unless other arrangements for payment are being made.

4 The operation of the Trust is governed by the Memorandum and Articles of Association which prescribe the rights of members. A member may ask for a copy of this document.

5 If you are eligible and willing to do so, **please also complete and return the Gift Aid Declaration at the foot of the page overleaf** in order to increase the value of your donation.
